Course Outline

This course will be offered in four different Universities in three countries: UFRJ and Unicamp /Brazil, Higher School of Economics, Saint Petersburg/Russia and Tata Institute of Social Sciences, Mumbai/India.

The aim is to present the major issues related to Social Stratification and Inequality in the BRICS countries. Nevertheless, its dynamics has as main objective to develop comparative research among the three countries, based on field work carried out by trans-nationally formed groups of students from the different institutions involved in the course. The research projects will address themes such as consumption, life styles, standards of living and social class. It will be necessary to develop a list of topics capable of stimulating debate between students, in this international context. That is why classes must be taught in English to promote the interaction among students.

The theoretical approach will be based on the analyses of the various dimensions of Sociology of Stratification focusing in the BRICS countries, with special attention being given to Theories of Stratification and Inequality, as well as, research methodology in this field. For these reasons, the course will be based aound the first book published in cooperation with four countries: Peilin, L; Scalon,C; Gorshkov, M. K.; Sharma,K.L..; Handbook Social Stratification in the BRIC Countries. Singapore, World Scientific. 2013. As for South Africa, we shall include some papers with research on this subject.

The aim is to study the differences and similarities among the BRICS countries and reinforce the importance for developing empirical research and substantive analyses about the theme in Brazil, Russia, India, China and South Africa. Therefore, our proposal is not only present the theoretical and methodological dimensions, but to advance by conducting comparative research during the course.

The course will be offered in English and the evaluation will be a paper written by students from the three countries based on themes related to Social Stratification. We believe it is a great opportunity to engage in an international network (and to practice global sociological research in English). The course is specially recommended for researchers interested in opportunities for academic mobility.
